Entry into force of amendments to the Protocol on POPs and the Protocol on Heavy Metals



- 20 January 2022 entry into force of the amendments to the text and annexes I, II, III, IV, VI and VIII to the Protocol on POPs (decision 2009/1)
- 1 more acceptance is required for entry into force of the amendments to annexes I and II to the Protocol on POPs (decision 2009/2)
- 8 February 2022 entry into force of the amendment to the text of and annexes other than III and VII to the Protocol on Heavy Metals
