Draft items for the 2024/2025 Work Plan

Introduction

The Executive Body, at its 43rd session, in December 2023, decided to launch a process to revise the Gothenburg Protocol, as amended in 2012, with the aim to conclude the revision by the EB_46.

In line with the outcomes of the discussion within the WGSR_62, for the implementation of the Convention, it is necessary to have updated information on available technologies and their characteristics.

TFTEI activities (cont'd)

Due to the huge work expected for the revision of the Guidance Documents, according to the timetable proposed by the Chair of WGSR and accepted by EB, in 2024, TFTEI has started the revision process of the Guidance Document on Stationary Sources, to be submitted to the 63rd WGSR in 2025, while the Guidance Document on Mobile Sources will be revised in 2025 and submitted to WGSR in 2026.

In the second trimester of 2024, TFTEI has contacted the Parties and industry experts to create a list of experts to be involved in comments and possible integrations to the revised text.

TFTEI activities (cont'd)

To comply with the editorial rules of the Secretariat and ensuring the complete information contained therein, in agreement with the Secretariat and the WGSR chair, the **official document** will be in form of summary to be presented and discussed during WGSR_63, in 2025.

For the above reasons, the official document will be sent to the experts for comments and integrations by the mid-November (deadline in one month).

The **draft side complementary informal document** on Stationary Sources will be finished by the end of October 2024. It will be sent to the experts for comments and integrations (deadline in one month)

Attention: only the official document will be approved by WGSR and finally adopted by EB.

The informal document will never be translated, discussed and approved by WGSR, or adopted by EB.

TFTEI future activities

In the 2025, TFTEI will start to update the Guidance Document on Mobile Sources, following the same process to involve experts for comments and integrations.

The aim is to have the draft revised Guidance Document on the Mobile Sources for the WGSR in 2026, again as **official document** in form of summary.

The update of the two GDs is essential for the revision of the Annexes to AGP, however the finalization of the work is pending waiting for the decision of the Parties on their future role and the approach (by sector, pollutant, step by step, etc.) which will influence the structure of the documents.

TFTEI continues to offer its techno-scientific support to the EECCA countries.
