## 44th session of the Executive Body

Geneva, 9-12 December 2024

- Adoption of the plan for the revision of the Gothenburg Protocol, as amended in 2012
- Adoption of the revised mandate and operational rules for the Implementation Committee
- Adoption of the revised rules of procedure for sessions of the Executive Body
- Changes in the Guidelines for reporting emissions and projections data
- Established an ad hoc group on open data
- Decisions on financial matters and elections



## 44th session of the Executive Body

Geneva, 9-12 December 2024

### **Revision of the Gothenburg Protocol:**

- Acknowledgement of strong support for the inclusion of methane;
- Overarching collective health and biodiversity goals should be aspirational and for the ECE region as a whole. Ambition level and timeline doesn't need to be the same as those for emission reduction commitments (ERCs);
- ERCs the core basic obligation that should be updated. Facilitate setting ERCs for non-Parties seen as a priority



## 44<sup>th</sup> session of the Executive Body

Geneva, 9-12 December 2024

#### **Revision of the Gothenburg Protocol:**

- Parties requested TFTEI, with the Bureau of the Working Group on Strategies and Review, to work on potential options to revise the technical annexes, taking into account the needs of non-Parties and using the proposal set out in the document "Preparatory work on the revision of the technical annexes to the present Gothenburg Protocol" to commence that work
- Requested the Working Group on Strategies and Review to further discuss the mandatory or non-mandatory nature, status and content of the technical annexes, taking into account any work progressed by TFTEI
- Invited Parties to send nominations of technical experts with relevant knowledge to support TFTEI in that work



# 63<sup>rd</sup> session of the Working Group on Strategies and Review

Geneva, 26-28 May 2025

- Reports by Task Forces, including TFTEI
- Draft revised guidance document on control techniques for emissions from stationary sources
  prepared by TFTEI: the document is forwarded to the Executive Body, and delegations are
  invited to submit views to TFTEI
- Draft revised guidance document on national nitrogen budgets forwarded to EB for adoption
- Draft guidance document on non-technical measures amended during the session and forwarded to EB for adoption
- Policy and capacity-building and outreach/communication parts of the draft 2026-2027 workplan



# 63<sup>rd</sup> session of the Working Group on Strategies and Review

Geneva, 26-28 May 2025

#### Revision of the Gothenburg Protocol:

- Methane: Recommended expressing support for GMP; including methane in the Protocol; Encouraged delegations to provide views and proposals on how to include methane in the Protocol;
- TAs and flexibilities: took note of TFTEI's work. Different views with respect to nature and content of TAs;
- ERCs: info presented by CIAM on modelling, including scenarios that could be used for deriving ERCs; approaches taken by Parties. Requested CIAM to develop integrated assessment scenarios for 2050 to support the development of aspirational risk-based goals;
- Method for setting biodiversity goals should be discussed by WGE and the EMEP SB.



# 11<sup>th</sup> joint session of the EMEP Steering Body and the Working Group on Effects

Geneva, 15-18 September 2025

- Review of the current workplan implementation and the science part of the draft 2026-2027 workplan
- A policy note on ex-post analysis for policymakers would be prepared by the Bureau of WGE for the Executive Body;
- Improvement of emissions reporting and adjustments under the Gothenburg Protocol;
- Other issues: Proposed decision on open data, e-course on effects



### **Intersessional HoD meeting**

Elsinore, Denmark, 20-23 October 2025

Advancing discussions on the revision of the Gothenburg Protocol:

- Black carbon
- Methane
- Ammonia;
- Emission reduction commitments
